The school uses Home Access Center to provide parents a way to student's assignments, current grades, absenteeism, and continued progress thought the year. The parents are provided the pin number to access the Home Access Center at Open House yearly. The parents are provided with a parent packet during open house which contains teacher's email address and prep period.

Communication folders are sent home with students on a daily basis allowing the teacher to stay in touch with the parents. These folders contain homework assignments, upcoming events notification, and child's behavior.

The school will provide parents progress reports every four and a half weeks containing information about their child's academic progress.

The school utilizes the district website, online forum, and school sign to provide information to the parents. The district website has the student handbook, proposed calendar, parent links, athletic schedules, lunch menus, and upcoming on Google calendar.
